

Subject: Empanelment of Printing presses

Indira Gandhi National Centre for the Arts is publishing research papers and books written by eminent scholars on culture and related subjects, reports, proceedings, catalogues, brochures, thesis, pamphlets. IGNCA is known for its publications globally. All the titles are being printed with utmost precision and with the best quality.

IGNCA intends to prepare a panel of Printing Presses who are capable to print the work assigned, ensuring the good quality of printing within the given timeframe. The requirement/criteria to decide the empanelment may be as follows:

Offset Printers

(Minimum requirements)

Page setting capacity

Press should have capacity to type minimum 50, A-5 pages per day and have all related accessories/fonts for typing in Hindi, English and Sanskrit language.

Desirable: Press should have arrangement for typing, Sanskrit (Devanagari) and other scripts with diacritical marks. Acquaintance of working with Vedic fonts will be an added advantage.

Proof Reading & Editing

Press should have well qualified team of proof readers for English, Hindi, Sanskrit and other regional languages.

Arrangement for editing of text, language editing of texts, caption making/marking etc. for improvement in the text and photographs, layout, designing etc. are expected to be available with the press.

Colour scanning planning equipment

Press must have arrangement with sister organizations equipped with digitized sophisticated scanners etc. so as to handle multicolour reflection objects and colour transparencies up to A3 size.

CTP with latest image ripping software to avoid manual intervention for better result should be available.

Printing Machine

(Minimum requirements)

Two colour offset printing machine-19"x25"/28"x40"-One number

Four colour offset printing machine-19"x25"/28"x40"-One number

(with facility of lamination, aqua coating etc.) and numbering (optional)

Digital Printing machine

Must have arrangement with sister presses having fully automatic Digital Printing machine-one number of A3 size.

Binding

Full binding facility under one roof or with arrangement for binding with some reputed bindery firm.

Technical staff

Absolute minimum strength of crews as required for running the machines and semi-skilled & unskilled staff required to assist in execution of jobs.

In addition to the above technical requirements the following financial and administrative requirements are also to be fulfilled by the presses.

Compulsory requirement of the Printer

PREREQUISIT REQUIREMENTS FOR REGISTRATION:

- Press should be located in Delhi/NCR.
- Press should have all the equipment, machinery to control pollution including STP running connection to dispose off the industrial waste.
- Registration and clearance from fire authorities, safety certificate, factory license and local police license to work as per the rule.
- Press must be registered with E S I as per government rule.
- A current certificate be attached that no child labour is engaged.
- Press should have annual turnover of Rs. 2 crores in total or the average for the last three years.
- Press must have ISO 9000
- IGNCA would review empanelment in every 18 months. It shall also seek fresh application from those printer that are not already empanelled.
- The registration of the press will be for three years only.
- Empanelment of press with IGNCA is not guarantee for allocation of work from IGNCA.
- The distribution of jobs will be done on rotation/roster basis based on entry in register after allocation.
- Competent authority may cancel; relax any or all terms/conditions without assigning any reason whatsoever.

REGISTRATION PROCESS

Presses to submit printed samples having print line on all samples.

- After scrutiny of the details submitted in the application form and examining the printed samples the category of the applicant will provisionally finalised.
- Once a provisional category of the firm is decided, physical verification
 of the press will be undertaken by team of officers/experts constituted
 by the competent authority.
- After technical examination and verifications of data, facts submitted and physical inspection

CANCELLATION OF REGISTRATION

- For change of address during empanelment, if any, prior information to be submitted.
- On change of address, if not informed in advance, the registration of empanelment will be cancelled without extending any reasons.
- The registration of empanelment may be cancelled at any time by competent authority without assigning any reasons, whatsoever.
- After expiry fresh application with all requisite documents to be submitted for fresh consideration of registration. No extension of registration will be granted under any circumstances.
