**Note:** It is a single storey structure with a foliated arch opening with a foliated arch opening framing a pointed/horse shoe arch doorway. It has a projecting terrace supported by brackets. It has a central courtyard, with a series of round arches on pillars, framing a porch in front of the post-tinted doorway. Lattice work decorate the spandrels of the arches and relied work the surface area.
