Section 5.1: Pre-qualification:

- i. **Clause no 6-** Eligibility criteria may be read as "Average Annual Turnover of Prime Bidder from its IT and ITES operations during the last three (3) financial years (FY 17-18, FY 18-19, FY 19-20) as per the last audited balance sheets of INR 10 crore."
- ii. **Clause no. 7** – Eligibility Criteria may be read as Average Annual Turnover of Joint Venture Partner along with Prime Bidder in Total from its IT and ITES operations during the last three (3) financial years (FY 17-18, FY 18-19, FY 19-20) as per the last audited balance sheets of INR 15 crore or more.
- iii. **Clause no. 8** may be read as Two completed / Substantially completed projects in IT Solution implementation for Government/ Public Sector Undertaking (PSU), each of minimum value of INR 2 crore. Those firms having implemented the IT solution /software Development /E governance Projects /ERP projects /SI projects including software Development shall be given preferential treatment. The projects should be executed in the last five years as on bid submission date.

Section 5.2: Technical Qualifications:

- i. **Clause no 1-a** -Description may be read as "The Prime Bidder or JV partner should have implemented Projects which includes: a) COTS/Open source software & system b) O&M phase c) Change management/capacity building/training"
- ii. The **clause 1-d of Section 5.2** may be read as - The Prime Bidder or JV partner should have provided Operation & Maintenance / Helpdesk services in the field of IT services with a minimum order size of INR 1 Crore (Value of O&M / Helpdesk component only)

Other General Points:

- iii. **Section 4** may be read as -
- i. EMD for Rs. 52.0 Lakh in the form of Demand Draft favouring Indira Gandhi National Centre for the Arts, New Delhi to be submitted along with Tender Document (DD to be kept in the envelope containing technical bid.
 - ii. Performance Bank Guarantee will be 5% of the total bid value.
 - iii. The Project value may be read as 25.72 Crore.
