Expression of Interest for art work installation of Ceremonial Foyers of 3 Ceremonial Entrances of New Parliament Building

The Indira Gandhi National Centre for the Arts, is visualised as a centre encompassing the study and experience of all the arts forms with its own integrity. It partakes of the holistic worldview articulated throughout Indian tradition. The arts are understood here to comprise the fields of creative and critical literature, written and oral; the visual arts, ranging from architecture, sculpture, painting and graphics to general material culture, photography and film; the performing arts of music, dance and theatre in their broadest connotation; and all else in fairs, festivals and lifestyle that has an artistic dimension. The IGNCA seeks to place the arts within the context of the natural and human environment.

IGNCA has been entrusted with various art works installations of the New Parliament Building, which is under construction in New Delhi. Once completed, it will be the seat of the Parliament of India. Accordingly, IGNCA is inviting Expression of Interest from reputed agencies for conceptualizing, designing and creating art works. The art works are suggested to be anchored in Indian ethos. Expression of Interest for art work installation of Ceremonial Foyers of 3 Ceremonial Entrances of New Parliament Building at New Delhi is requested from the interested artists/agencies.

Interested artists/bidders who have experience of creating art work with multiple artists may submit the EOI for the above work.

PROCESS OF SELECTION

IGNCA would be detailing the minimum pre-qualification requirements and the process of selection in the EOI

- The designated Committee would evaluate the quality / capability of artists/ Bidders on the criteria mentioned in the EOI based on their proposals received and fulfilment of eligibility criteria. The eligible artists/ agencies would be called to make a presentation before a designated Committee at IGNCA, New Delhi.

- The artists/bidders shall submit their offers strictly in accordance with the Terms & Conditions of the EOI document. Any bid that stipulates conditions contrary to the conditions given in the EOI document stands disqualified.
- The EOI should be submitted online on the CPP portal latest by **5.00 P.M.** on **23.07.2022** and the EOIs will be opened on **25.07.2022 at 3.00 P.M.**
- Pre bid queries: All queries regarding the EOI can be mailed to IGNCA directoradmn.ignca@gmail.com on **18.07.2022 by 3.00 P.M.**
- The artists/bidders shall bear all costs associated the preparation and submission of the Tender and IGNCA will in no case be held responsible or liable for these costs, regardless of the conduct or outcome of the tendering process.
- IGNCA also reserves the sole right for carrying out amendments/modification/changes including any addendum to this EOI. Such amendments/modification/changes including any addendum to this EOI shall be notified on the IGNCA website www.ignca.gov.in and on CPP portal and these will be binding on the agencies.
- IGNCA does not bind itself to accept the bid and has the right to refuse any or all the bids without assigning any reason or select any bidder that is in the final evaluation list. IGNCA also reserves the right to re-issue the EOI without bidders having the right to object against such re-issue. IGNCA also reserves the rights to extend the validity period.
- IGNCA reserves the right to extend the deadline without assigning any reasons thereof. Intimation of the same shall be notified on the IGNCA website www.ignca.gov.in and eprocure.gov.in

Scope of Work

Scope of work for the agency shall be as below-

In the New Parliament Building has 3 ceremonial entrances. These ceremonial entrances will welcome its guest with the display of ceremonial foyers showcasing the Indian art, culture, ethos and patriotism. Each ceremonial gate has been given a theme associated with the proposed art work. The suggested themes for the foyers are Gyan, Karma and Shakti.

The artworks will be made from brass weighing not more than 2 tons each. There is 7 by 7-meter wall space to display the art work. Each foyer is supposed to appear as a memoir of Indian patriotism, Indian knowledge system and Indian artistic traditions.

Following are the suggestive list of the proposed concept.

- It augurs well with the rich heritage of Indian culture
- Is symbolic of the people's aspirations
- Is rooted in the country's ethos
- Manifests inclusiveness
- Element of our rich history may be appreciated.
- To be taken as ornamentation or Alankaran which will be embodiment of our shared cultural heritage.
- To capture the spirit of the Constitution of India which is all about equality, equity and harmony.

As the art space is in the foyer which is a prominent space of the building, it must have the ability to show case apt and suitable symbolism of rich cultural heritage of India.

QUALIFYING CRITERIA

IGNCA shall evaluate the capabilities of the artists/bidders based on their profile / presentation and also keeping in view of the following criteria.

Minimum Eligibility Criteria

a) A Bidder can be an individual artist/ company/ partnership firm/other legal entity incorporated/established as per the applicable laws in India. A consortium/Jointventure of entities shall be allowed to bid and shall be considered for evaluation under this EOI.

b) (i) The Artist should have the experience of at least 10 years in the field of art either as professional/ teacher or work in the industry. They should submit their experience proof through experience certificate from Government or reputed Educational institutions/Industry/ Newspaper Cuttings/ or exhibition catalogues.

OR

b) (ii) The bidding agency must be in operation in India at least from past 5 (five) years in the same line of business. As proof the agency may submit copy of Invoices/workorders/agreement copies/Purchase Order of any assignment executed in the last 5 years before the EOI due date.

c) The artists/ agencies should also submit the details regarding Exhibitions/ dealing in Art work/ Art Gallery projects and other similar works for any Government Organization/ PSUs /Chambers of Industry Association in last ten years. At least 03 (three) will be desirable.

d) (i)The artists should also submit the last 3 years IT returns viz. FY 2018-19, 2019-20 and 2020-21.

d) (ii)The agency must have attained annual turnover of Rs. 50 lakh in any of the last three financial years 2018-19, 2019-20 and 2020-21 from the same line of business. A certificate from practising CA in this regard must be submitted as proof along with audited Balance sheet and Profit & Loss Account.

e) The net worth of the bidder, as on 31.03.2021 should be positive.

EOI Proposal

The agencies fulfilling the pre-qualification criteria will be asked to make a presentation before a committee constituted by the IGNCA for this purpose.
