Scope of Work:

The scope of work for the proposed conservation project shall include the following activities:

- Documentation, Cleaning, Mending, Strip lining, Consolidation, Lining (if required), Filling and in-painting.

A detailed proposal must be submit as per annexure 'A'.

Terms and Conditions for Conserving Thangka Paintings

Total No. of Thangka Paintings:- 120

1. Eligibility Criteria

- The bidder should have more than 05 years of experience in the field of conservation of paintings.
- The bidder must provide documentation to support their experience and qualifications.
- The bidder must visit the site (Patna Museum, Patna) to assess the condition of the Thangka paintings before quotation submission.
- Agency must have done conservation of textile. Any proof of the work must be attached.

2. Conservation Timeline

- The conservation work must be completed within 1.5 - 2 months from the date of allocation of work.

3. Quality and Standards

- The conservation work must meet the highest standards and traditional of Thangka Painting.
- The bidder must use materials and techniques that are suitable for the conservation of the Thangka Paintings as per conservation practice.
- The agency must follow to the proposed timeline and ensure timely completion of the project.

4. Payment Terms

- The payment terms will be as follows:
 - 25% payment after 30 thangka painting conservation.
 - 25% payment after 60 thangka painting conservation.
 - 50% payment after completion of the all- thangka paintings.

Note: A conservation treatment report including documentation, condition assessment & conservation treatment has to be submitted after conservation of every object.

5. Liability

- The agency will be liable for any damage or deterioration of the painting during the conservation process. In this case the agency will be blacklisted for future conservation practice.

6. Evaluation Criteria

- The proposals will be evaluated based on the bidder's experience, qualifications, and the quality of the proposal.
- The evaluation criteria will include the bidder's approach to conservation, the timeline, and project costs.
